

WHAT IS THE GOLD CARD?

- In February 2018, the *Act for the Recruitment & Employment of Foreign Professional Talent* was implemented by the National Development Council to attract highly-skilled professionals to Taiwan.
- New amendments to the *Act for the Recruitment and Employment of Foreign Professionals* were passed in June of 2021. These amendments aim to provide more attractive work and residence conditions; optimize rent, tax, social security, and other related rights; and establish a more complete legal framework for recruiting and retaining more international talents.





4-IN-1 CARD

Allows cardholders to seek employment freely, obtain employment at any time, work any part-time job legally, and freely change jobs.

WORK PERMIT

Permit to legally work fulltime, part-time, or freelance for any Taiwanese employer



ARC
A physical card with an identity number used for daily living in Taiwan

RESIDENT VISA

Long-term visa which allows cardholders to stay in Taiwan for up to 3 years.

RE-ENTRY PERMIT
Allows unlimited entry and
exit from Taiwan (even
during COVID restrictions).

BENEFITS OF THE GOLD CARD

OPEN WORK PERMIT

- Start a business
- Investor, Consultant
- Self-employed,Remote work
- Employed by multiple companies
- Art performance

RESIDENT VISA

 Spouse and children can apply for residency in Taiwan.

NATIONAL HEALTH INSURANCE

- Cardholders who are employed in Taiwan professionally can join the NHI system, with their dependent relatives.
- Employers or selfemployed business owners, with their dependent relatives, can join the NHI system without having to wait for six months.

INCOME TAX DEDUCTIONS

 Eligible for income tax deductions

Lineal relatives
 can apply for
 visitor visas with a
 maximum stay of
 up to one year.

• For specialist professionals, or those who have received national recognition, in one of the nine listed Fields. Each applicant needs to select one qualifying criteria within a Field.











SUBMITTING ADDITIONAL DOCUMENTS & REJECTION

If you submit incomplete or unclear information, or the authorities require more information about your qualifications, you will receive a request to submit additional documents for review.

If there are additional documents needed, the process will take a few more weeks to review.

If you do not submit required supplementary documents within 6 months, your application will be summarily rejected by the Workforce Development Agency, and you will not be refunded.

If you switch to a new Field or regulation, or there are new regulations for the Field of the previous application, the platform will not be able to transfer your documents from your previous application.



FAQ



Q. How do I check the status of my application?

A. Please login to the online application platform or check your email.

Q. If I apply from abroad, how can I enter Taiwan?

A. Please print out the "Republic of China Employment Gold Card Overseas Approval Certificate" from the application platform. Since July 28th, applicants can enter Taiwan with this certificate.

Q. What identities are not eligible to apply for the Gold Card?

A. Mainland Chinese citizens, R.O.C. Nationals living in Taiwan with household registration

Q. Do my documents need to be verified?

Philippines, Thailand, Vietnam, Malaysia, and Indonesia.

A. An overseas ROC representative office must verify documents from the following countries/regions: Afghanistan, Algeria, Bengal, Bhutan, Myanmar, Cambodia, Cameroon, Cuba, Ghana, Iran, Iraq, Laos, Nepal, Niger, Nigeria, Pakistan, Senegal, Somalia, Sri Lanka, Syria,

FAQ

Precautions for gold card application during the COVID-19 pandemic

- As of May 2021, all overseas missions and representative offices have suspended visa applications (including the passport inspection of the gold card application).
- As of September 2021, if you are at the passport inspection stage, and you or your family have an urgent need to enter Taiwan, and are fully vaccinated, please contact the Gold Card Office who will help expedite your passport inspection and apply for emergency visas for your family to enter Taiwan.
