

## 應備文件 Required Documents :

1. 本處轄領內，政府或官方開立之死亡證明「正本」。Deceased's original death certificate.  
(正本文件為佛羅里達州政府開立。以下地區死亡證明須經當地 Apostille 程序: 波多黎各、美屬維京群島、巴哈馬、百慕達、英屬土克凱可群島及多明尼加)
2. 詳填及親簽「文件證明申請表」乙份。Complete and sign "Application for Authentication".
3. 亡者中華民國護照正本。Deceased's original ROC passport
4. 亡者僑居國護照(或居留證)影本乙份 Deceased's passport or resident copy of the country of residence.
5. 申請人所持有效中華民國及僑居國護照(或居留證)影本乙份。Applicant's valid ROC passport copy and valid passport/resident card copy of the country of residence.
6. 申請人須為亡者之直系血親，並提供關係證明文件(例如:結婚證明、出生證明等)。Applicant must be deceased's lineal descendant, supporting documents are required.
7. 規費。Application Fee (請參考下方說明 Please refer to the information below.)
8. 回郵信封(含郵資)。Self-addressed stamped envelope.

## 費用 Fee :

1. 每份美金 15 元。Each certificate is \$15.
2. 本處僅接受美金匯票、Cashier's Check 或現金 (僅限親自來處辦理)、私人或公司支票一概不受理。受  
款人請填 **Taipei Economic and Cultural Office in Miami**。We accept money order, Cashier's check or cash  
(in person ONLY), make payable to **Taipei Economic and Cultural Office in Miami**.

## 辦理方式及作業時間 How to Apply & Process Time :

一般案件於文件備齊後 5-7 個工作天後核發或拒件。

Document process time is 5-7 business days.

1. 本人親自至辦事處申請：申請人應出示有效身分證件正本及影本一份。  
**In Person:** Applicant is required to bring valid passport and a copy.
2. 以郵寄方式申請：申請人應出示有效身分證件影本一份。郵寄辦理請自行提供足夠回郵郵費及回郵信封，限代寄美國郵局或 FedEx。

**By Mail:** Applicant is required to mail in “Required Documents”. If applicant is a minor, also provide legal guardian’s valid passport copy, signed permission letter, and proof of guardianship. Applicant shall provide sufficient postage or label. Our office provides services by USPS or FedEx only.

**死亡證明中譯本驗證說明 Remarks on the Chinese translation:**

1. 中文翻譯本不得單獨申請驗證，需搭配原文文件一併申辦。Translation cannot be process by itself, the original document is required to accompany the translation.
2. 官方正本上的條碼序號不同，中譯時請務必正確表示；若申請多份，中譯時請務必配合將條碼數字正確表達。Each official original has a unique barcode number. Please be sure to translate it accurately. If you're submitting multiple copies, make sure each barcode is correctly reflected.
3. 中文翻譯請以繁體字為準。Translation shall be in Traditional Chinese.
4. 中文翻譯本請加入下列聲明文字：Translation shall include the following declaration:
