

應備文件 Required Documents :

1. 詳填「現居國外證明書」乙份。Complete “Proof of Residency in Foreign Country” form.
2. 詳填及親簽「文件證明申請表」乙份。Complete and sign “Application for Authentication”.
3. 申請人所持有效中華民國護照影本乙份。Applicant’s valid ROC passport copy.
4. 所持有效僑居國護照(或居留證)影本乙份。Applicant’s valid passport/resident card copy of the country of residence.
5. 所持有效僑居地駕照或 ID 影本乙份。Applicant’s valid state license or ID copy.
6. 規費。Application Fee (請參考下方說明 Please refer to the information below.)
7. 回郵信封(含郵資)。Self-addressed stamped envelope.

費用 Fee :

1. 每份美金 15 元。Each document is \$15.

辦理方式及作業時間 How to Apply & Process Time :

一般案件於文件備齊後 5-7 個工作天後核發或拒件。

Document process time is 5-7 business days.

1. 本人親自至辦事處申請：申請人應出示有效身分證件正本及影本一份。
In Person: Applicant is required to bring valid passport and a copy.
2. 以郵寄方式申請：申請人應出示有效身分證件影本一份。請使用證明書郵寄辦理格式，所檢附證明書須先經有效之佛州公證人(Florida Notary Public)公證，並附註公證人聯絡電話及傳真號碼。郵寄辦理請自行提供足夠回郵郵費及回郵信封，限代寄美國郵局或 FedEx。

By Mail:

Applicant is required to mail in “Required Documents”. Applicant shall use Proof of Residency by Mail format, the document is required to be signed and stamped by a Florida Notary Public, also enclosed notary’s contact information. Applicant shall provide sufficient postage or label. Our office provides services by USPS or FedEx only.
