What is “**Entrepreneur Visa**”?

The Government of Republic of China encourages and welcome the foreign innovative Entrepreneurs to set up innovative businesses in Taiwan.

The applicant, who is qualified as “Innovative Entrepreneurs”, can apply for residence visa.

Visa process

1. Online Visa Registration

Print out the filled Visa form and sign.

2. Submission

- Passport photocopy, the passport validity should be more than 6 months
- Highest Education degree and transcript (at least 12 degree)

- Visa application form, signed on the second page.
- Visa Request Letter from the applicant, stating the visa purpose, and which type of “Entrepreneur visa ”
- 2 Passport size Photos(60% face, 3.5 cm*4.5 cm)
- Other requirements: Please check on the website of INVESTMENT COMMISSION, MOEA, for the detail, and (http://www.moeaic.gov.tw/system_external/ctrl?PRO=LawsLoad&lang=1&id=80)
- One more extra copy of all the mentioned documents, including visa application form.

4. TECC will refer the visa application to INVESTMENT COMMISSION, MOEA, which is the competent authority for verification of the application. INVESTMENT COMMISSION will inform TECC the verification result. TECC will then issue the visa accordingly. It will take at least 7 weeks for visa verification. TECC will inform the applicant if the visa is issued or not. Visa fee and the passport original will only be entertained if the visa issuance confirmed.

Visa fee

Applicants should pay the visa fee only if the visa is confirmed to issue. Applicants should deposit either cash or demand drafts to any branch of Kotak Mahindra Bank in New Delhi, account No. 9411166749, in favor of Taipei Economic and Cultural Center. Collect the payment slip and submit to TECC with Visa Form

創業家簽證審核及申請流程

The Qualification for Foreign Nationals for applying Entrepreneur Visa

為提高國外創業家來臺創業誘因，行政院開辦「創業家簽證」，針對具創新能力及技術的外國及港澳（不含大陸地區）創業家，提供來臺創業者 1 年的居留簽證，並可視創業實績申請延長居留。

外國人士符合創業家資格者，可於我國內向外交部遞件申請，或在居住所在地向我駐外館處申請，再轉由經濟部審查。

遞件流程

1. 上網登錄並列印簽證表格(<https://visawebapp.boca.gov.tw>)

3. 遞件：申請人可向我國外交部或者住居地之我國駐外館處申請

- 有效期超過六個月護照之護資頁影本
- 簽證申請表，第二頁須簽名
- 簽證申請說明書，請敘明簽證申請理由以及所將申請之創業家類別
- 兩張色彩白背大頭照(尺寸：3.5 cm*4.5 cm)
- 有關申請創業家相關資格及所需專業文件，請自本處網站下載，或查閱經濟部投資審議委員會網站：1
http://www.moeaic.gov.tw/system_external/ctrl?PRO=LawsLoad&id=79
- 上述所有文件請另備一份影本。

4. 駐印度代表處於接受創業家簽證申請之相關文件後，將函送主管機關經濟部投資審議委員會審查，並將視委員會之決定據以核發簽證。所有處理程序約需 7 週時間。

駐印度代表處將另行通知簽證是否核可。倘可核發簽證，本處將通知申請人繳交護照正本以及簽證費用。倘未獲核可核發簽證，則無需繳交簽證費用。

本處簽證費用繳交方式：

請於印度境內任一 Kotak Mahindra Bank 分行，將簽證費用匯入本處帳戶，帳號 9411166749，帳戶名稱 Taipei Economic and Cultural Center in India。取回匯款證明單作為簽證費用繳交證明。居留簽證費用：3960 印度盧比。
