# 2025 MOE Huayu Enrichment Scholarship (HES) Application Guidelines

In case of any discrepancy between English version and Chinese version, the Chinese version of <u>"Ministry of Education Huayu Enrichment Scholarship (HES) International Student Directions"</u> shall prevail.

# 1. Purpose

To encourage South Asian students/applicants to undertake Mandarin courses in Taiwan; in order to provide them with opportunities to increase their understanding of Taiwanese culture and society, and to promote mutual understanding and interactions between Taiwan and the international community.

### 2. Award Value

A monthly stipend of 25,000 NTD. (Approximate Rs. 65,447)

## 3. Duration

- a) Huayu Enrichment scholarship may last 3 months, 6 months, 9 months or 1 year respectively.
- b) The duration of the scholarship is from September 1st this year to August 31st of the following year. If recipients fail to come to Taiwan for enrollment during the designated time, they will forfeit their right to retain their scholarships.
- c) Scholarship funding will become effective on the date of the recipient's enrollment. Scholarship funding will end according to the scholarship's expiration date or if the scholarship is revoked.

# 4. Eligibility

Applicants above the age of <u>18</u>, who possess a <u>high school diploma or above</u>, have shown excellent <u>academic performance</u>, and are of <u>good moral character</u> are eligible, and "Transcript/Certificate of Test of Chinese as Foreign Language (<u>TOCFL</u>)" is required to apply for Huayu Enrichment Scholarship. Level of the result is <u>not</u> mandatory. (If you pass level of Novice, Band A, b or C, you will have a transcript and a certificate issue by the Minister of Education Taiwan and the certificate is recognized by the US,

Canada, Australis, New Zealand, EU countries and so on. If not, you will receive transcript only.) Upload TOCFL result into the additional document in the application system.

Candidates with one of the following qualifications <u>cannot</u> apply:

- a) an overseas Chinese student or a national of the R.O.C. (Taiwan)
- b) Currently registered as a student at a Mandarin Language Center in Taiwan or has sought a degree from a university or college in Taiwan.
- c) Has already received a HES or a Taiwan Scholarship, in the past.
- d) An exchange student to Taiwan, during the scholarship period.
- e) Currently receiving financial benefits from the Taiwan government or another educational institution.

# 5. Application

For admission, the applicant has to apply it through university language center (Mandarin Language Center).

For scholarship(funding), applicants need to apply through online system before March 31st, 2025.

NOTE: Convert your CGPA to GPA

1>Multiply your CGPA by 9.5.

2>Divide the result by the total number of credits you've earned.

Example: CGPA =  $8.5 \rightarrow GPA = (8.5 \times 9.5) / total credits$ 

#### 6. Selection Procedure

A document review and personal interview will be conducted. "Preference" will give to an applicant studying in Taiwan Education Center or with TOCFL certificate or transcript / IELTS (5.5 or above). If a successful candidate waives his/her right to a scholarship before arriving in Taiwan, his/her position will be filled by the candidate in waiting list selected by TECC in India.

## 7. Terms and Conditions for Recipients

- a) The recipient should study at a registered Mandarin Language Center approved by the MOE. (<a href="https://lmit.edu.tw/lc/school">https://lmit.edu.tw/lc/school</a>)
- b) The recipient should apply for admission according to the regulations of the center. Once admitted, the recipient should send a photocopy of the admission letter to Education Division, TECC in India before June 1<sup>st</sup> for confirmation. Recipients who do not send their documents before the deadline will be disqualified from the scholarship selection process.
- c) The recipient should undertake at least 15 hours of language courses each week. This does not include cultural visits, speeches, and other self-learning curriculum or activities.
- d) The recipients are not allowed to apply to transfer to another Mandarin Language Center.
- e) If the recipient concurrently accepts scholarships from other sources, he/ she will lose their placement in the scholarship program. He/she will also have to return the funds granted for those months that he/she received multiple scholarships.
- f) The termination and cancellation of a scholarship is based on regulations specified by each individual Mandarin Language Center. Mandarin Language Centers have the right to terminate or revoke a scholarship if the recipient's academic performance, moral character, or attendance record are not up to their standards.
- g) <u>Recipients of a six month or longer scholarship are obligated to join the National Health Insurance Program.</u> Before joining, recipients should purchase student accident insurance and other relevant insurance. Insurance fees can be deducted by the Mandarin Language Centers from the monthly stipend before granting it to recipients.
- h) Recipients are <u>not allowed</u> to work in Taiwan during the award period.
- i) <u>Recipients shall send photos/words to Education Division, TECC in India, regarding what they have learned while living in Taiwan and how they felt about their study experience, for future reference on official social media.</u>

## 8. Suspension and Cancellation

- A. The Scholarship will be suspended for one month, if one or more of the following conditions occur.
- a) The Scholarship will be suspended for one month, if the recipient has missed 12 hours or more of their language course within a single month.
- b) Starting from the first semester (quarter), if the recipient fails to obtain the specified standard score by the university (an average of 80 points out of 100), his/her scholarship will be suspended for a month in the next semester (quarter).

- c) The recipient of a nine month or longer scholarship without a (Band B1) Level 3 or above TOCFL certificate within 2 years prior to enrollment must hand in the certificate or transcript one month before the end of the scholarship term. If he/she fails to do so, the scholarship will be suspended for one month.
- B. Scholarship cancellation, if one or more of following conditions occur.
  - a) The recipient fails to obtain the standard score (an average of 80 points out of 100) for two consecutive semesters (quarters), he/she will be disqualified from receiving the scholarship.
  - b) Any recipient missing a final achievement score for any semester (quarter) will be disqualified from receiving the scholarship with the exception of a serious illness or accident.
  - c) The recipient will not continue to receive the scholarship if he/she violates R.O.C. (Taiwan) law.
  - d) The scholarship will be suspended or revoked if the recipient violates

    University or Mandarin Language Center regulations.
