

## Visa for Visiting Relative Purpose for stays of less than six months

	<b>Requirements</b>	<b>Description</b>
1	Application form	Fill out the application form at <a href="https://visawebapp.boca.gov.tw/">https://visawebapp.boca.gov.tw/</a> and print it out. Make sure the application form displays a bar code. Sign the completed application form.
2	Two color passport-size photos	Two color passport-size photos with a white background taken within the past 6 months, attached to the application form.
3	Passport ( Original and one photocopy)	<ol style="list-style-type: none"> <li>1. Applicant's passport must have remaining validity of at least six months as well as blank pages.</li> <li>2. One photocopy of the passport bio-page, including the passport-holder's picture, is required.</li> </ol>
4	Proof of relationship	<ol style="list-style-type: none"> <li>1. For visiting spouse :               <ol style="list-style-type: none"> <li>(1) marriage certificate (within 3 months)</li> <li>(2) one photocopy of the passport of the spouse residing in Taiwan.</li> </ol> </li> <li>2. For visiting parents (applicant under 18-year-old) :               <ol style="list-style-type: none"> <li>(1) Birth certificate or Household Registration (within 3 months)</li> <li>(2) and one photocopy of the passport(s) of the parent(s) residing in Taiwan.</li> <li>(3) letter of Consent from both parents or legal guardian(s).</li> </ol> </li> </ol>

Dutch documents must be legalized by the Dutch Foreign Ministry (Consulair Dienstencentrum, CDC).</li> <li>2. For documents of other foreign countries, the legalization of our Representative Office in the issuing country is required.</li> </ol>
5	Proof of relative's residence in Taiwan	<ul style="list-style-type: none"> <li>● Household Registration Transcript within 3 months (personal family registry information should be indicated in the notes column of Household Registration Transcript)</li> <li>● Or Alien Residence Certificate</li> <li>● Or Permanent Residence Certificate.</li> </ul>
6	Other supporting documents	<ol style="list-style-type: none"> <li>1. Round trip flight ticket.</li> <li>2. Proof of residence: <ul style="list-style-type: none"> <li>● For EU citizens, a residence certificate issued by local municipality.</li> <li>● For non EU citizens, Dutch resident's permit.</li> </ul> </li> </ol>

## **Application Procedure**

1. Applicants are to submit their applications, with necessary documents and fees.
2. Our office may require an interview if necessary.

## Visa processing fees :

- Standard: €47 (single-entry); €95 (multiple-entry)  
Processing time: 5 working days
- Priority service: €71 (single-entry), €142 (multiple-entry).  
Processing time: 2 working days
