

2026 Taiwan Long-Term Care Industry Visiting Program for Overseas Compatriot Entrepreneurs Information & Registration Guidelines

I. Purpose and Objectives:

With many advanced nations around the world entering aging societies, the long-term care industry has emerged as a key global priority. In alignment with Taiwan's "Long-term Care Plan 2.0" and the "Healthy Taiwan Cultivation Plan," Taiwan leverages its competitive industrial capabilities in health diagnostics and fitness technologies, nutrition and wellness services, smart transportation applications, and intelligent assistive technologies.

To enhance overseas compatriot entrepreneurs' understanding of Taiwan's long-term care industry, its current development, and potential collaboration opportunities, the Overseas Community Affairs Council organizes a visiting delegation to invite overseas compatriot entrepreneurs engaged in the long-term care sector, or those with relevant experience, to visit Taiwan for exchanges and partnership exploration. Through firsthand engagement with Taiwan's industry ecosystem, participants will gain insights into market developments, innovation trends, and partnership opportunities, thereby promoting the international expansion of Taiwan's advanced technologies and services and fostering mutually beneficial outcomes.

II. Program Date:

September, 29 (Tuesday) to October, 3 (Saturday), 2026, for a total of 5 days and 4 nights.

III. Eligibility for Registration:

Participants must possess proficiency in Mandarin, and be engaged in the long-term care industry or related fields abroad, or be interested in investing and capable of assisting Taiwan's long-term care industry in expanding into international markets. Priority will be given to those who have not participated in OCAC's economic and trade workshops or visiting delegations in the past two years. This program will not be held if there are fewer than 15 participants.

IV. Registration Information:

A.Registration Period: From now until 24:00 on May 31, 2026 (Taiwan Time).

Late registrations and waitlist applications will not be accepted.

B.Registration Method:

1. This program utilizes the “**OCAC Overseas Compatriot Affairs Activity Registration System**”. Applicants are required to complete the registration process on the website (<https://register.ocac.gov.tw>) prior to the registration deadline.
2. The collection, processing, and use of participants' personal data will be handled in accordance with Article 8 of the Personal Data Protection Act. Applicants are advised to review the relevant disclosure carefully and provide consent by selecting the designated option in order to proceed with registration.
3. Applicants registering via an “i Compatriot Card” account will have selected personal data fields automatically populated, **including names, date of birth, gender, contact information, card number, and country of residence**, to streamline the registration process. Cardholders who have not log in with their “i Compatriot Card” account should ensure that the card number field is completed accurately. Applicants who have not yet obtained an “i Compatriot Card” are required to indicate their consent to apply for one, and OCAC will issue the card based on the registration information provided.
4. Applicants **are required to provide a valid and frequently-used email address** to ensure receipt of notifications regarding application results and online check-in instructions.
5. Initial review of the overseas compatriot attendee application will be handled by the Culture Center or OCAC overseas offices and furthered reviewed by the OCAC. OCAC will send registration results to the applicants via email.

V. Program Agenda:

The entire event will span 5 days and 4 nights, featuring visits to relevant government agencies and institutions related to Taiwan's long-term care industry, thematic seminars on industry trends, visits to the “7th Care Expo Taipei, 2026”, corporate visits and exchanges, a business matching meeting, and a comprehensive panel discussion. (Please refer to the provisional itinerary for the

preliminary schedule. The final itinerary will be confirmed upon OCAC's approval. OCAC reserves the right to adjust the agenda as needed according to actual operational circumstances.)

VI. Cost Allocation:

A. Expenses Covered by OCAC:

Lunch and dinner, accommodation, group transportation, visits, insurance, and venue expenses during the event.

B. Expenses to be Borne by Participants:

1. Round-trip airfare and related transportation expenses between the participant's place of residence and Taiwan, as well as transportation costs to and from the designated check-in location, and other personal expenses.
2. Twin-share accommodation (two participants per room) will be arranged during the event. Participants requesting a single room will be responsible for paying the price difference. Requests for early check-in or late check-out should be submitted in advance and are subject to hotel availability. All relevant expenses will be borne by the participant.
3. During the program, participants will be provided with travel accident insurance coverage of NT\$2 million, including medical expense coverage of up to 10% of the insured amount. Participants who consider the coverage insufficient are advised to purchase additional insurance at their own expense. Any medical expenses incurred during the program due to illness or infection treatment shall be borne by the participant.

VII. Notice:

- A. Only one participant per household or company is permitted. To ensure proper group management, companions (including family members and assistants) are not permitted to accompany participants during the event.
- B. Approved participants will only be confirmed as eligible to join the program

after receiving the notification and completing the “confirmation of participation” procedures with the designated organizer.

- C. As the schedule is intensive, participants are advised to assess their health and physical condition to ensure they are able to fully participate in all activities. To ensure effective use of program resources, participants are expected to attend the program in its entirety. Participants may not be allowed to leave the group without prior approval from OCAC, except under special circumstances. Individuals who are unable to fully participate are advised not to apply.
- D. Applicants are advised to purchase round-trip airfare only after receiving official confirmation of acceptance. If participants experience any symptoms of discomfort prior to check-in or during the event, they should **immediately notify OCAC or staff members and refrain from attending the activities.**
