<b>For disabled or ill travelers</b>	Auxiliary means and equipment necessary for traveler's medical control and mobilization (wheel chair, stretcher, crutches, blood pressure meter, temperature meter, glucose meter, others), which are carried by disabled or ill travelers	Reasonable for travel
<b>Currency</b>	Currency in cash and/or negotiable monetary instruments in United States dollars or equivalent in another currency	Less or equal to US\$ 10,000

#### IMPORTANT WARNING

- ▶ The Customs Authority is entitled at any moment of the process to check, register and inspect the traveler, crew and carried baggage or packages.
- ▶ Undeclared items will be seized by the customs authority. In order to retrieve the items, the traveler must pay the corresponding duties and a penalty equal to 50% on the customs value of the items, prior compliance with customs proceedings (Legislative Decree No. 1053 – General Customs Law and amendments).
- ▶ Failure to declare or false statement in declaring currency in cash and/or negotiable monetary instruments will result in their temporary withholding and the application of a penalty equal to 30% of undeclared value (Law No. 28306 and amendments).

## RED CIRCUIT: ITEMS TO BE DECLARED

If you carry items or articles included in the following list in your baggage, **please fill out a Baggage Sworn Declaration** and go to the exit through the red circuit.

CLASSIFICATION	OBSERVATION
<b>Baggage and/or items paying duties</b>	Items or articles not considered in the listing detailed as "nothing to declare", up to US\$ 1,000, pay 12%. For higher amounts, taxes applicable to an importation are paid.
<b>Items excluded from the Procedure of Baggage and Household Goods</b>	<ul style="list-style-type: none"> <li>▶ Parts or spare parts of motor vehicles, motorcycles, mopeds or ATVs, motor homes or trailers; boats of all kinds including jet skis and aircrafts.</li> <li>▶ Items owned by residents in border areas (subject to special regulations).</li> </ul>
<b>Restricted items</b>	<ul style="list-style-type: none"> <li>▶ Agricultural products.</li> <li>▶ Flora and fauna.</li> <li>▶ Cultural heritage.</li> <li>▶ Medical and dental equipment.</li> <li>▶ Weapons and ammunition.</li> <li>▶ Others, according to specific rules.</li> </ul> <p>They require authorization from one or more competent entities for their entry.</p>
<b>Prohibited items</b>	<ul style="list-style-type: none"> <li>▶ Used clothing and footwear not owned by the traveler</li> <li>▶ Drinks manufactured abroad with the denomination "pisco"</li> <li>▶ Used auto parts</li> <li>▶ Others, according to specific rules.</li> </ul> <p>They are prohibited from entering the national territory and will be seized.</p>
<b>Items for temporary entry</b>	<p>Goods, equipment or tools that are individually identifiable, for professional or technical use, have to be placed in the process of temporary entry and a guarantee should be deposited for an amount equivalent to import duties.</p> <p>The non-resident traveler may enter sports goods for the development of adventure tourism activities, and professional equipment corresponding to foreign press without a guarantee deposit.</p>
<b>Currency in cash and/or negotiable monetary instruments</b>	<ul style="list-style-type: none"> <li>▶ You must file a declaration if you carry more than US\$ 10,000.</li> <li>▶ No more than US\$ 30,000 is allowed to enter.</li> </ul> <p>Note: In both cases, if applicable, its equivalent in national or foreign currency should be considered.</p>
