

南非_短期研習華語六個月簽證規定

Visitor Visa Application to Study Mandarin in Taiwan

Requirements:

1. Please use Google Chrome to complete the online Visa Application Form on <https://visawebapp.boca.gov.tw>
 - Choose the General Visa Application (complete all 7 pages of the application and submit the application).
 - Make sure you choose the correct PURPOSE of travel to Taiwan.
 - Once submitted, print the form in PDF, It should be 2 pages with a barcode on the bottom –right corner, then sign it. (Make sure your signature is as is in your passport)
 - Make sure that ALL your dates, names and all other information on your application form corresponds with your supporting documents. **Incorrect Application forms will not be accepted.**
 - Hand in the Visa Application Form, together with the following, at the Taipei Liaison Office in South Africa.

(PLEASE MAKE SURE APPLICATION FORM 'S GIVEN NAME AND SURNAME ARE EXACTLY AS IS ON PASSPORT.

Print the visa application form to submit to Taipei Liaison Office.

2. Original passport and passport copy. (must be valid for a minimum of 6 months after travel).
3. Two **2-inch standard passport photo** -sized colour photos, taken against a white background (taken within the last 6 months).

(Please do not re-submit photos used in a previous visa)

Please note that your photo must be between 3.2 -3.6 CM from the top of the head to the chin .

4. Admission Letter from School .

5. Your study plan (include the motivation and study plan for studying Mandarin)

6. Authenticated highest degree/diploma .

7. Authenticated Transcript.

8. Authenticated Police Clearance. (kindly note that the police clearance is only valid for 3 months from the date of issue, for the visa application)

9. Personal CV .

10. 3 months the latest personal bank statements.

This has to be the applicant's bank statement.

(E-stamp or print stamp from the bank is acceptable).

11. Flight booking showing the departure date from South Africa and return ticket.

12. Prove of accommodation .

13. Free Visitor Visa Charge for South Africa passport holders .
(CASH ONLY ,NO CHANGE) / 21 working days.

14. Consular services are booking essential.

15. REMINDER: Please make sure that you hold a passport that is under our Consul's list of countries permitted to apply for visas at our office.

16. Applicants need not to apply in person. A friend, family member, agent or courier can submit and collect visa applications at their own risk and personal expense.

17. It is the applicant's responsibility to check with their Courier Company, agent or relative if their Visas/certifications have been submitted or are ready for collection. We do not arrange submissions and collections with any parties. **DO NOT DROP YOUR APPLICATION IN OUR POSTBOX.**

18. The Taipei Liaison Office in the RSA reserves the right to withhold the application and request further information, including supporting documents and/or an interview with the applicant, should it be deemed necessary.

19. Applications will only be processed once all the required documentation is received. Submission of Visa application does NOT guarantee that the visa will be granted nor the approval of the number of days the applicant applied for will be granted should the visa be approved.

20. The Consular office will not print any documentation on the applicant's behalf unless there is communication requiring additional documentation after submission. It is the applicant's responsibility to make sure that their application meets the requirements.

21. The Taipei Liaison Office in the RSA reserves the right to withhold the reason behind a rejected visa application.
