2. 必要時中華民國駐外館處將要求申請人面談。

注意事項

1. 簽證核發為國家主權行為，中華民國政府有權拒發且無須說明原因。提出簽證申請者不論是否獲發簽證，已繳之簽證規費依法不退還。
2. 停留簽證規費及美國籍人士申請簽證之相對處理費收費數額，請參考「外國護照簽證收費數額表」。
