

外國專業人才申請來臺尋職簽證審查及核發作業辦法

條文	說明
第一條 本辦法依據外國專業人才延攬及僱用法(以下簡稱本法)第十九條第四項規定訂定之。	明定本辦法授權依據。
<p>第二條 外國人具下列條件之一者，得向駐外機構申請尋職簽證：</p> <p>一、 有工作經驗者，近六個月內之月平均薪資或報酬不低於中央主管機關依外國人從事就業服務法第四十六條第一項第一款至第六款工作資格及審查標準第八條公告之數額。</p> <p>二、 畢業一年內且無工作經驗者，須為教育部公布之全球排名前五百大學畢業。</p> <p>三、 經外交部會商中央目的事業主管機關認定者。</p>	明定外國人申請尋職簽證之條件。
<p>第三條 符合前條所定條件之外國人向駐外機構申請尋職簽證，應檢附下列應備文件：</p> <p>一、 尋職簽證申請檢核表。</p> <p>二、 中華民國簽證申請表。</p> <p>三、 外國護照正、影本。</p> <p>四、 尋職計畫書。</p> <p>五、 近六個月內之月平均薪資證明。</p>	明定外國人申請尋職簽證之應備文件。

<p>第四條 駐外機構受理外國人申請尋職簽證，經檢視應備文件齊全後即予受理，並在審查無虞後，由駐外機構核發三個月效期、多次入國、停留期限六個月之停留簽證。</p> <p>駐外機構審查後，倘對申請人之資格有疑義，得轉送外交部，由外交部轉請中央目的事業主管機關協助審查其資格。</p>	<p>明定外國人申請尋職簽證資格審核方式，以及尋職簽證類別、入境次數及停留期限。</p>

The Regulations Concerning Review and Issuance Procedures for Employment-seeking Visa Applications Submitted by Foreign Professionals (hereinafter referred to as the Regulations) have been established in accordance with Paragraph 4 of Article 19 of the Act for the Recruitment and Employment of Foreign Professionals.</p>	<p>Providing legal basis for the Regulations</p>

4.護照正本及影本	效期 6 個月以上且須有空白頁 (不含臨時護照、緊急護照)

申請程序

1. 由申請人檢具各項應備文件及簽證規費向中華民國駐外館處申請停留簽證入境。
2. 必要時中華民國駐外館處將要求申請人面談。

注意事項

1. 簽證核發為國家主權行為，中華民國政府有權拒發且無須說明原因。提出簽證申請者不論是否獲發簽證，已繳之簽證規費依法不退還。
2. 停留簽證規費及美國籍人士申請簽證之相對處理費收費數額，請參考「外國護照簽證收費數額表」。

2. Interview may be required when necessary

Notices :

1. Visas are issued as stipulated by Article 12 of the Statute Governing Issuance of ROC Visas for Foreign Passports. As a sovereign nation, the ROC has the right to refuse applications for visas without providing any explanation for such decisions; visa application fee is not refundable.
