Abbreviations or cursive styles are not allowed. If there is any omission or unrecognizable part, the authority may request the applicant for correction. Once any falsehood is found, the authority shall deal with it in accordance with law. Sections 1 to 8 are a must. Fill in 'Nil' if 'Also known as' or 'National ID Card No.' is not applicable. Fill in other spaces wherever is appropriate for the purposes of contact or emergency help.

Note: 1. Use two identical photographs taken within the last six months: color, 35x45mm, front, profile, hatless, clear facial features, uncovered ears, neutral facial expressions, mouth closed (teeth not shown), white background, glossy paper (no tinted eyeglasses unless medically necessary). Paste one photograph here; paste the other by its left edge to the box on the left. 2. The length from the top of the head to the bottom of the chin must be between 32mm to 36mm. The head or hair must not touch the top of the photograph. 3. When wearing eyeglasses (thick frames not allowed), the frames must not cover any part of the eyes. 4. Photomontages are not allowed. *For first-time applicants who do not have preferences for spellings, Scheme of the Chinese Phonetic Alphabets (Hanyu Pinyin) is recommended for transliterating the Chinese name into English. Yet, phonetic transcription of the "surname" should be the same with the ones of the relatives to avoid confusion.

Note: 1) Sections 11, 12. Must be filled out. 2) Regarding signature, Applicants should sign in person at the "Applicant's signature" regardless of whether they are applying or not. For applicants under 7 years of age and applicants under guardianship, please ask the legal representative to sign, such as OOO (mother's representative); for applicants who are over 18 years of age and unable to sign, please use fingerprints or seal instead of signature.

For the first-time applicant, please paste copies of nationality proof (e.g. parent's nationality document(s) together with applicant's birth certificate/Resident Certificate for the Taiwan Area) inside the box and present the originals for verification. A copy of "parent's Agreement on Child's Surname" should be filled out and submitted herewith.

For minor applicant under the age of 18, please paste a parent's or a guardian's (the original guardianship certificate should be presented for verification) copy of the identification certificate and present the original for verification.
