- ※ Mereka yang memasuki Taiwan dengan Visa Resident harus mengajukan Izin Tinggal Orang Asing (ARC) dan Izin Masuk Kembali dalam jangka waktu 15 hari dari hari kedatangan di masing-masing pusat layanan daerah (kota) Badan Imigrasi Nasional. Durasi tinggal didasarkan pada masa berlaku yang tercantum di Izin Tinggal Orang Asing (ARC)
- ※ Those who enter Taiwan on a Resident Visa must apply for an Alien Resident Certificate and Re-entry Permit within 15 days from the next day of arrival at local

service centers of National Immigration Agency.  
Duration of stay is noted on the Alien Resident  
Certificate.
