I. Introduction

Asian Network of Women's Shelters (ANWS) is part of the Global Network of Women's Shelters (GNWS) and a regional alliance of Asian Women's Shelters. The members come from 14 different Asian countries, including Bangladesh, Cambodia, Hong Kong, India, Japan, South Korea, Indonesia, Mongolia, Malaysia, Nepal, Singapore, Timor-Leste, Vietnam, and Taiwan. ANWS aims to promote mutual learning, capacity building, and initiatives among shelter-related organizations in the regions of Asia. The Garden of Hope Foundation is the secretariat of GNWS and ANWS.

From 2018 to 2020 the Garden of Hope Foundation launched the Three-Year Project of the Asian Network of Women's Shelters (ANWS), which received the constant support from the Ministry of Foreign Affairs. Our mission is to prevent as well as to eliminate sexual abuse, sexual exploitation, and domestic violence against women and children, dedicate to social transformation and create a friendly environment for women and children with our determination and courage to pursue justice and love. We take international development as our strategy and sharing our shelter experience as our core concept to pass on our values to Asia.

We have long noticed the insufficiency of emergency shelters and the need for midto-long term shelters. In 2012, we launched a service plan called Go the Second Mile, which deals with financial, housing, and relationship repairing issues. Services include employment assistance, economic assistance (including supplies provision), housing assistance (including mid-to-long-term shelter, independent accommodation, renting assistance, finding DV-friendly landlords/real estate agents), legal assistance, relationship advice, and so on. The purpose of providing these resources is to meet the needs of women trying to rebuild their lives and accompany them to gain independence.

In order to incorporate social housing and provide long-term support after women leave the shelters, the Garden of Hope Foundation has looked at shelters and housing in Taiwan and invited lecturers from countries with better social housing development to share their mid-to-long-term housing experiences. Also, we will invite UN representatives and local organizations through the board of GNWS and ANWS, and key political officials in Asia through the R.O.C. Embassies to this online meeting to discuss how to provide midto-long-term social housing for women.

II. Objectives

Through holding this online meeting, ANWS Annual Meeting: From Shelters to Social Housing – How to Construct a Housing Safety Network for DV Victims, we hope to achieve the following goals:

- 1. Connect ANWS members and promote our well-grounded shelter services to the world, allowing Taiwan to exercise real influence and civil power;
- 2. Learn from countries with better social housing development and share our experience.
